

Wayne Glew's legacy of failure

Reading through any cases in the higher courts, you are bound to notice that the court frequently refers to other judgments on specific points of law, and relies on those judgments as an answer to the particular question. This is due to a common law principle known as *stare decisis*, or precedent, it is the body of law collected from legal decisions, which is applied to future similar cases. This principle means that judges are obliged to respect the precedent established by prior decisions.

The words originate from the Latin maxim *stare decisis et non quieta movere*: “to stand by decisions and not disturb the undisturbed.” In a legal context, this is understood to mean that courts should generally abide by precedent and not disturb settled matters. Under the doctrine of *stare decisis*, common-law judges are obliged to adhere to previously decided cases, or precedents, where the facts are substantially the same. A court's decision is binding authority for similar cases decided by the same court or by lower courts within the same jurisdiction. The decision is not binding on courts of higher rank within that jurisdiction or in other jurisdictions, but it may be considered as persuasive authority.

Wayne Glew was involved in many failed cases, all of which contained contentions which the court rejected, and hence when those particular contentions arise in subsequent cases, the courts invariably refer to these decisions as an accurate statement in law regarding the specific question. Wayne Glew is very active on social media, and in complete ignorance of the principle of *stare decisis*, continues to impress on others the very contentions that were rejected in his own cases. This has resulted in those who believe in his ‘teachings’ to attempt those very same contentions again in their own cases, which inevitably results in them following their guru into their own failure in the courts.
